7. Highways - speeding

7.1 FPC has received a quotation for a second VAS (vehicle activated sign) of either compact 300mm''30'' + SLOW DOWN - £2520 or 450mm ''30'' + SLOW DOWN - £3000. Following a site meeting with OCC highways, it was decided to position the VAS towards Burford on A361, at bus stop just west of Carpenters Arms. WI suggested fundraising in village to pay for this item. Following discussion about alternative signage and whether the VAS offered value for money it was decided that:
